

How to Become a Member of EMR

Provisional Membership is granted to all applicants for REALTOR® membership when completed application and payment of association dues and MLS fees are submitted and paid during your appointment with the EMR Association Executive. Provisional members shall be considered REALTORS® and shall be subject to all of the same privileges and obligations of membership. The applicant must satisfy all of the requirements of membership, *i.e.* completion of a mandatory orientation classes within thirty (30) days from submission of the REALTOR® application, or membership may be terminated, at the discretion of the Board of Directors.

 - * Smart Card Authorized User Agreement (Signed by Agent & Broker)
 - * REALTOR® Association Marketing Consent Form (Signed by Broker)
